

Unless you are a sophisticated client or a third party payer (both as defined in the Act) who would be a sophisticated client if you were a client of our firm ('Sophisticated Client'), you may seek a costs review outside the time limit, if the Supreme Court of the ACT ('Supreme Court') determines that it is just and fair to do so. If you are a Sophisticated Client, our Business Terms however require you instead to make any application to have our costs assessed within 4 months of the bill receipt or payment. If the amount payable in this bill is claimed under a costs agreement, under section 286(2) of the Act mediation may be used to resolve any dispute over an amount we claim to be payable. You have a right under section 288 of the Act to apply to the Supreme Court for an order to set aside our costs agreement or a provision of it on the basis that it is not fair or reasonable, where you make such application within 6 years or such other time as the law permits.

The current interest rate charged in accordance with our costs agreement on unpaid bills is the rate applying from time to time under schedule 2, part 2.2 of the Court Procedures Rules 2006 (ACT) in respect of unpaid judgments in the Supreme Court.
